More Information: Both bills allow a terminally ill, mentally capable adult with a prognosis of six months or less to live, who is a resident of Minnesota, the option to request, obtain and take medication — should they choose — to die peacefully in their sleep if their suffering becomes unbearable. The bills are modeled after the Oregon Death with Dignity Act, which has been in practice for 20 years without a single instance of abuse or coercion.

"For centuries systemic racism has contributed to stark and persistent racial disparities in health, education, public safety, and wealth and financial well-being. These disparities can be traced back to government-sanctioned laws and policies that have created a system built on racial inequality where inequity is entrenched in our systems. Government-sanctioned racial discrimination created these inequities and only racially-conscious policies can address the inequities. Each year that goes by without addressing systemic racism costs our state and nation billions of dollars. It is imperative on the Minnesota Legislature to make amends for past and present harms by prioritizing the enactment of laws and policies designed to address racial disparities and expand access to opportunity to build a prosperous state for all Minnesotans."

Redistricting Moves To A New Stage But Our Work Is Not Over

Congressional District lines have been drawn by the courts and are posted at: Minnesota Judicial Branch - A21-0243 (mncourts.gov)

While much attention is given to congressional and legislative redistricting during the redistricting cycle, few are aware that every ten years all Minnesota counties, city councils, and school districts where school board members are elected by election districts are also required to review population and demographics changes and adjust district lines as necessary. Since few people are aware that local redistricting occurs and this process does not receive much publicity, there is very little public involvement. We need to continue to be vigilant as elected officials can make decisions on who votes for them with limited public involvement or transparency.

We only need to remind ourselves about the number of services provided by local governments and the amount of funding and resources they control. County governments in particular provide a wide range of services including law enforcement and corrections, public safety, parks, medical services, road maintenance and construction, housing development, and elections.

Observer Corps Reports

St. Louis County Board Meeting February 1, 2022

The Regular Meeting began at 9:31 a.m.
The meeting was held at the Duluth Government Services (

The meeting was held at the Duluth Government Services Center, Duluth, MN. 6 out of 7 commissioners were present. (Commissioner Musolf was absent due to illness.)

One citizen, Nancy Watkins, of Rice, MN, addressed the Board, announcing that she is taking over as Co-Chair of the Aquatic Invasive Species (AIS) division of the Vermilion Lake Association and thanked the Board for their support.

The Consent Agenda was approved unanimously. Item #13, request for Sponsorship of Pathblazers Snowmobile Club Trail Grooming Equipment Purchase was pulled for separate consideration.

The Regular Agenda included a resolution moved by Commissioner P. Boyle, supported by Commissioner A. Grimm, to contract with SISU Healthcare IT Solutions for the time period January 1-December 31, 2022, for up to \$450,000 in American Rescue Plan Act (ARPA) funding to support the increased capacity of skilled registered nurses to assist PHHS with COVID-19 response efforts, to coordinate with regional facilities, evaluate and assess facilities for risk, providing training for the prevention and control of COVID-19, and provide direct clinical services to St. Louis County residents. Administration requested that the resolution be amended to change the beginning contract date to February 1, 2022. There were no objections. Commissioner Nelson moved to amend, supported by Commissioner Jugovich, the resolution to state that the first \$225,000 for this program be paid from ARPA funds and the second \$225,000 by paid from Public Health Initiative funds. Following contentious discussion and input from PHHS Director Linnea Mirsch, the amendment was withdrawn and the resolution passed. Commissioner Nelson expressed interest in reconsideration of the resolution at the next Board meeting, so Commissioner Musolf could offer input and vote.

Item #13 (from the Consent Agenda), request for Sponsorship of Pathblazers Snowmobile Club Trail Grooming Equipment Purchase was discussed. Commissioner Jewell, supported by Commissioner Boyle, moved that St. Louis County make application to the Minnesota Department of Natural Resources for the Federal Recreation Trail Program and to sponsor the purchase of snowmobile trail grooming equipment on behalf of the Pathblazers Snowmobile Club at no cost to the County; that if the County is awarded a grant, the County agrees to accept the grant, and may enter into an agreement with the State of Minnesota for the above referenced project. Motion passed unanimously.

Meeting adjourned at 10:20 a.m.

Observer Corps Reports

St. Louis County Board Meeting February 8, 2022

The Regular Meeting began at 9:30 a.m.

The meeting was held at the Duluth Government Services Center, Duluth, MN.

7 out of 7 commissioners were present.

Three public hearings were conducted:

- 1) Resolution to consider the issuance of an Off-Sale Intoxicating Liquor License to Side Lake Store, LLC dba R & B Side Lake Store, French Township. Passed unanimously.
- 2) Resolution to consider the issuance of an Off-Sale Intoxicating Liquor License to Country Corner Bar, LLC dba Country Corner Bar, LLC, Culver Township. Passed unanimously.
- 3) Resolution to consider the request for tax abatement financing regarding the City of Duluth Cirrus Aircraft's conversion and expansion plan at the Duluth International Airport.

 Passed unanimously. NOTE: Cirrus Aircraft plans to convert the former (now empty) Northwest Airlines/AAR maintenance building. Expansion will mean an increase of 80 new jobs. Cirrus is requesting a \$600,000 tax abatement over 10 years from the County and will also request a \$600,000 tax abatement over 10 years from the City of Duluth.

The Consent Agenda was approved unanimously. Item #4, bid to Mesabi Bituminous, Inc., was sent back to administration for more work.

The Regular Agenda included 3 items:

- 1) <u>From the Environment & Natural Resources Committee</u> Commissioner Jugovich, Chair: Sale of certain state tax forfeited lands to the Fond du Lac Band of Lake Superior Chippewa. Approved unanimously. (<u>NOTE</u>: The land parcels are in the Brookston and Culver areas.)
- 2) <u>From the Central Management & Intergovernmental Committee</u> Commissioner Jewell, Chair: Request for sponsorship of Ashawa Ski Club trail grooming equipment. Approved unanimously. (<u>NOTE</u>: Sponsorship by the County is needed for the club to accept a grant, which would be in the amount of \$15,000, approximately.)
- 3) Commissioner Nelson initiated a motion for reconsideration of a resolution passed at the Board meeting on February 1. Motion approved 4:3. (Nelson, McDonald, Jugovich, Musolf in favor; Jewell, Boyle, Grimm opposed.) Commissioner Nelson initiated a motion to amend the original resolution to contract with SISU Healthcare IT Solutions for the time period February 1 December 31, 2022, to support the increased capacity of skilled registered nurses to assist PHHS with COVID-19 response efforts, to coordinate with regional facilities, evaluate and assess facilities for risk, providing training for the prevention and control of COVID-19, and provide direct clinical services to St. Louis County residents for up to \$450,000 funded with the first \$225,000 paid from American Rescue Plan (ARPA) funds and the second \$225,000 paid from Public Health Initiative funds. Motion passed 4:3. (Nelson, McDonald, Jugovich, Musolf in favor; Jewell, Boyle, Grimm opposed.)

Observer Corps Reports

City of Duluth Natural Resources Commission Meeting, January 5, 2022

The meeting was held virtually and began at 6 p.m. The primary items on the agenda were the Strategic Public Lands Realignment Project and the Natural Resources Management Program Plan.

Strategic Public Lands Realignment Project – Jim Filby Williams reviewed the public lands strategy, which proposes a 3-pronged approach to protect approximately 2400 acres of tax-forfeit open space. Lands are divided into 3 categories – 75% of the identified lands will be designated as parklands; another 16% will fall into the Duluth Natural Areas Program (DNAP), with 60% of these parcels being in the St. Louis River corridor. Williams stated that these lands will have "adequately robust protections" because a supermajority of both the City Council and the Planning Commission is required to change the designation. The remaining 9% of identified lands are smaller, isolated parcels in otherwise developed areas that are on steep slopes, are wetlands, or important for water management but do not meet the requirements for parks or the DNAP designation. State statute limits protections to 30 years for lands conveyed for less than market value; after that, another strategy would be needed for these parcels. Staff is considering a recommendation to create a third category for long-term protection of lands important for stormwater and floodwater management. Commission members indicated support for this, and would like to see a stronger statement in the plan about a commitment to pursue this. Concerns were also expressed about protections for Hawk Ridge and wildlife corridors within the City.

Revisions to the strategy will be made in January, with a return to the Commission for discussion at the February meeting. More information about the Strategic Public Lands Realignment Project is available here: https://duluthmn.gov/planning-development/public-lands-realignment/

Natural Resources Management Program Plan – Diane Desotelle solicited feedback on the plan, which had been presented to the Commission at the December meeting and available for review on the City website. Issues brought forward included problems loading maps, the format and appearance on different types of devices that might be used to view it, the intended audience, how to make it more accessible, and the feasibility of integrating summaries since the plan is dense. The intended audience is primarily City staff and project partners, not necessarily the public.

New Business – The 2022 meeting schedule was discussed. Meetings will remain on the first Wednesday of the month at 6 p.m. and decisions about need/cancellation will be made on a month-to-month basis.

Forester's Report – Clark Christensen presented a year end update on 2021 activities. Below is a summary.

455 trees were removed in 2021, mostly ash, due to emerald ash borer (EAB)

387 trees planted – lower than normal due to EAB and the pandemic

2125 trees were pruned

Trees planted included 25 genera and 40 different species.

56 trees were ordered but not received

EAB continues to be a driving force for removal – 1620 ash trees remain on City streets

Senescence of silver maple is also an issue

Replacement and succession of trees in parks needs to be a priority, with emphasis on parks that lack trees. Enger Park is a particular concern. Some trees were planted on Indian Point in the last year and a half.

Upcoming in 2022:

Sourcing trees through an RFQ, contract growing and growing a limited number themselves; Developing an urban forest management plan – Rochester has just completed one at a cost of \$85,000.

Director's Report – Jim Filby Williams had no formal report. In response to a question about how the Commission can stress to the City the importance of filling the Natural Resources position when Diane leaves, Williams responded that the position is fully funded in the budget, the position description is written and the process is lined up and ready to go. The hope is to have someone in place before Diane leaves.
