The Time is Now to Speak Up for People Powered Fair Maps



Our May Voter left us uncertain about the future of our 8th Congressional District. The good news is that we were able to maintain our 8th Congressional District representation. The other news is that we were only able to maintain that representation by a Census Count of 29 people. I can't help but believe that we kept the 8th District in large part to the efforts made by our members to participate in phone banks and distribute census materials. Kudos to all that volunteered. Special thanks to Linda Vukson who kept us all informed and motivated.

Now that the 2020 Census is complete and we have secured the 8th District, our work to ensure that fair maps are drawn to represent our communities and are focused on shared interests and common needs. Our region is more diverse that ever and the new lines should be drawn to reflect that diversity. Remember we will live with the results of this redistricting for at least the next TEN years.

We were given an introduction to Redistricting at our Citizens in Action event last January. We are scheduling another opportunity for our members, community and faith-based partners to learn next steps to take action to influence how those lines are drawn. The 1 ½ Community Mapping training will be held by Zoom on **September 23rd** (time to be determined). You will receive an invitation to the training with more information early in September. **SAVE THE DATE!!**

Your input is critical because the Federal, State, County, City, and even School Board districts will be determined by hearings either by the Courts or local elected officials. If our voices are to be heard, we need to be prepared to ask for what we need and present alternative maps to meet those needs. Our Federal redistricting will be determined by the Minnesota Supreme Court. A hearing for the 8th Congressional District was held in Bemidji on August 10th. You can stream that hearing at View Council Meetings - Bemidji, MN. Start the video at about the 33:47 point.

When redistricting is based on partisan politics and not on populations it becomes another potent, insidious, and long-lasting form of voter suppression. We can't be lulled into complacency by the fact that we have had divided government for many years. Redistricting can change that as soon as 2022 if the voices of communities of common interest are diluted by lines that divide their votes.

We have been informed that New Citizens' Naturalization Ceremonies have been moved from Duluth to Minneapolis until 2023. We are sad to lose this unique and inspiring opportunity to register voters at this event.

1. Update on the Baywalk Project

- Focus of the Baywalk Project was consideration of repairs and upgrades to the area behind DECC. This could include upgrades to the seawall to enable cruise ships to dock.
- A major consideration will be whether to close off most of Harbor Drive to cars while keeping it open for pedestrians, biking, and delivery and sanitation vehicles.
- Five Guiding Principles for the project are detailed in full report.

2. Parks and Rec Master Planning Overview

- The city recently signed an agreement with consultant to lead development of new 10 year Master Plan for Parks and Rec. Timeline for completion is summer 2022.
- Community input will be key to process. *More information including key considerations and City of Duluth contact info is in full report.*

3. Public Golf Committee Update

• The City has begun discussions of the Enger Golf Course Renovation Project with consultants. Two issues are (1) accessibility and (2) where public golf fits in the recreational offerings of the community. Presentation of key concepts for the renovation may be as early as August Commission meeting.

4. Highlights of P&R Divisional Reports

• P&R Dept fully budgeted for staffing but still down 30% due to lack of qualified applicants. Senior dining centers serving meals are now operating as usual.

- 1. Library Staffing: Continuing to hire staff to attain pre-COVID staffing levels
- **2. Library Access:** Branches have now opened with "Library Express" concept. Patrons spend limited time and are masked. *See full report for details*
- **3. Every Child Ready Duluth:** Continues to meet with community action teams to develop strategic plan. There will be funding from City of Duluth to continue program through 2022 as previously committed.
- **4. Library Services/Programming:** Home delivery not available yet due to high reliance on volunteers. Annual Friends of Library Book Sale may not happen until 2022. Mini sales possible. Outdoor programing planned for summer. In-door programming last service to be resumed when safe. New Virtual Reality equipment available for use in library.
- **5. Library facilities:** New internet cabling being installed at main library to upgrade internet service.
- **6. Library Advocacy Group** met with Mayor Larson and Noah Schuchman. *See full report for details.*

- **2. Library Access**: All facilities are now open to public including computer access at branches. Hours will increase as staff expands.
- **3. Summer library programming** is in full swing including outdoor programing at branches. See full report for details
- **4. Every Child Ready Duluth** participated in the 4th Street Wellness Festival at the Damiano Center on June 15th. Details in full report.
- 5. Library Facilities
 - Main Library rearrangement and internet cabling project continue. See full report for details.
 - Art Installation at Mt Royal Library should be completed by end of June.
- **6.** Some **American Rescue Act (ARA) dollars** received by City of Duluth may to go to library but restrictions on how dollars can be spent need to be better understood.

- 1. Two amendments to the **Hunting Deer by Bow** Ordinance were unanimously approved:
 - decreasing required setback from active structures from 400 to 250 ft.
 - expediting "hotspot" determination to better react to changes in deer patterns.
- 2. **Invasive species Control** work continues in many locations in City. *See full report for details*.
- 3. **Emerald Ash Borer control** remains a priority for City Forester. *See full report for details*. Efforts continue to finalize **acquisition of tax forfeit property**. A final set of parcels may be presented to Planning, Parks, and Natural Resources Commissions in mid to late summer.
- 4. Sustainability Coordinator Mindy Granley may talk with the NRC regarding her charge to develop a response to Duluth's recently declared Climate Emergency. *See full report for details*.

- 1. Meeting focused on discussion of **Strategic Public Lands Realignment Project** See July 7 links for details
- 2. Director of Parks, Properties and Libraries ,Jim Filby-Williams, requested that the Commission approve the total of 2500 acres of over 1000 tax-forfeit parcels. Discussion that commissioners were not give enough time to review proposal prior to request to approve and did not have questions answered.
- 3. Commission approved the first parcel list presented by city staff for the five project areas, and Director Williams listed seven specific points describing a closer, integral relationship between City staff and NRC for the selection of future parcels; all approved. In addition, Commissioners requested that they receive information about actions required for permanent protection of acquired parcels
